## UConn Landscape Photography Exhibit Is Part Of Trust's Awareness Campaign

From a wall hung with a grid of Plymouth Rock photos to the opposite wall which contrasts Eadweard Muybridge's panorama of pre-earthquake San Francisco with a 1990 recreation of the same view by Mark Klett, the new show at the University of Connecticut's Benton Museum samples the diversity of American landscape photography.

The exhibit, "Landscape: Fact and Fiction," was organized by Janet Pritchard, a UConn professor and Joshua's Trust member.

As the title of the exhibit suggests, there's much more to a landscape photo than the "reality" it depicts. Janet ex-

plains that the photographs "provide the viewer with a sampling of the ways the photographer can interpret ideas and beliefs about landscape, as well as convey feelings."

The show, which is on view until March 2, is co-sponsored by Joshua's Trust and is part of a larger campaign to create greater public awareness of the Trust.

President Madge Manfred expressed her gratitude to Steven Kern, the new director of the Benton, for giving the Trust the opportunity to be involved with the exhibit.

He welcomed Trust members and others to the festive opening reception on January 19.

## April 17 Session: Learn Your Conservation Options

If you own a significant piece of land, what are your options for conservation?

An informational meeting for landowners is being held to explain the many possible answers to that basic question. Several town commissions and private conservation groups, including Joshua's Trust, are sponsoring an April 17 meeting at the Mansfield Municipal Building, from 7-9 p.m.

Not everyone who wants to preserve family land can afford to donate it to an organization such as Joshua's Trust. Many creative solutions have been developed and more government funding is now available to help landowners realize their hopes for conservation. The April 17 meeting will present information on various options, including conservation easements, the prac-

tical aspects of financing, as well as tax and legal implications. Each landowner's situation is unique, depending on whether the land is farm or forest, and the family's assets.

# Strength In Numbers

By the end of 2006, Joshua's Trust had 850 paid memberships, almost half of which were family memberships.

This is the largest group of supporters in our 41-year history!

We reached that number because a core of present and past board members contacted their circle of friends and encouraged them to join.

I especially want to thank Jane Blanshard, John Hankins, and Corine Norgaard for their exceptional efforts.

If you are one of our new members, WELCOME to a great organization. I hope you will come to the annual dinner meeting to socialize with like-minded folks and celebrate the Trust's recent accomplishments.

I am tallying the number of hours donated by our many volunteers, and it is an astonishing total. My rough estimate is 4,500 hours, which translates into \$90,000 of labor. Of course, there is no way to really put a dollar figure

on the quality of commitment from our volunteers; they are truly priceless.

One of the most outstanding volunteers has been our pro-bono attorney, Steve Bacon, who is relinquishing that role after seven years. To say that no one can replace him is not hyperbole, but fact. Three attorneys have

agreed to share the workload that Steve has carried: William Daikin, Mary Healey, and Danielle Omasta. Each brings a special expertise: estate and tax law, real estate, and litigation.

The last set of numbers I want to mention is the increased environmental funding proposed by Gov. Rell in her two-year budget: a total of \$20 million for the DEP's open space programs; \$10 million for farmland preservation; \$1.6 million to help municipalities enhance their GPS information; and \$2 million to help them upgrade local plans for conservation and development.

## Stewardship Report

### Griffin To Lead Reorganization Committee

A major reorganization of stewardship activities is underway. Hill Bullard has stepped down as Chief Steward, but will continue his work on boundary definition and marking. The number of properties has grown to the point where one volunteer cannot be responsible for coordinating all stewardship.

Before long, Joshua's Trust will need professional staff in this area. Garry Griffin, a long-time steward and former

trustee, agreed to act as interim chair of the stewardship committee and lead a subcommittee charged with developing a new structure.

A report from the subcommittee will be discussed at the March meeting of the Board of Trustees. The new structure should be in place by the time of the annual meeting. Meanwhile, stewardship activities continue during the winter months, primarily on boundary issues.



## Annual Meeting To Feature Food, Wine and Wildflowers

Bill Cullina, author and director of horticultural research for the New England Wild Flower Society, will be the featured speaker at the annual dinner meeting, scheduled for March 27.

By then, spring will have officially begun and the forest will bloom as woodland wildflowers reach for the sun. Bill will take us on a colorful tour of our local woods, letting us in on the secrets of the "mysterious lady-slippers, changeable jack-in-the-pulpit, promiscuous violets, fairy bells, merry bells and stinking Benjamin."

The meeting will be held at the Hole-in-the-Wall Gang Camp, Paul Newman's 300-acre fantasyland for seri-
